The total purse will be divided by three (3 days). Each day's purse will be split evenly among those winning for that day. If there are no winners for a particular day, the un-won prize money will be split evenly among the purses of the remaining days.

In the event that there are no winners on the last day (Sunday), the un-won prize money will be evenly split among the previous 2 day's winners. If there are no winners for the entire tournament, the money will be carried over to 2027.

Example: Let's say the total purse for the "Leaderboard Lotto" B Reward is \$54,000. That figure would be divided by 3 (3 days) giving each day a purse of \$18,000. Those who are in this Calcutta and remain on the leader board at the end of each day's weigh-in will evenly split the purse for that day.

If there is only one winner, they would take the entire \$18,000. Two winners would get \$9,000 each and so on.

***** Level I is exclusively for vessels that ARE NOT equipped with Omni Directional Sonar.

Added Levels: E1, E2, E3, F, G, H, I, M, N, O - Can only win in one (1) category, Single Heaviest or Heaviest Stringer, not both.

Cash awards will be paid via check and available within two weeks following the tournament.

Each winning team must fill out a disbursement form with the payee name, address and SSD/EIN number before the check will be cut.
